2. All CPC invoices must carry designation & Name of Force. For retired personnel please prefix with "Retd."

Ø Discount structure on MSIL models is same as that of CSD (Discount on dealer Margin & Discount on EX. Showroom).

Ø CPC (or BSF) pricing to be prepared by RO-ISL Managers for circulation to Dealer & CPC network.

**Submission of CPC Claims**

Ø The Process for submission of claims has being revised from June'18.

Ø As per the new process, all claim documents need to be scanned in a single PDF format document using a document scanner.

Ø The Individual Claim need to be uploaded into the DMS

Ø The detailed claim process is attached in the e-mail

Ø **CPC Purchase Order/ Letter of Intent is mandatory to be sent along with claim other than the standard claim documents.**

Ø **SALE TYPE should be selected as "CPC" while invoicing in DMS.**

**Checking of Submitted Claims**

All previous claims received at HO are being thoroughly checked and validated before settlement. Claims without proper documents or not having necessary Proof will be rejected.

**IMPORTANT NOTE:** Dealership needs to ensure that claims are passed onto genuine Eligible customers only after taking necessary documents as per ISL guidelines.
